Course structure

15 units are delivered over 48 weeks of training, delivered over 52 weeks:

- 40 weeks of classes and tutorials •
- 6 weeks work placement (2 days / 15 hours per week)
- 4 weeks holiday breaks

Total course duration can vary depending on the individuals existing knowledge, experience & commitments.

Delivery and assessment

Delivered with a mix of hybrid face-to-face class time, online work, project work and industry experience at MCIE's Melbourne CBD Campus. Hybrid delivery allows participants to attend in real time, remotely, or sitting in a classroom supported by teachers and students.

Assessment for this program includes written tasks, long and short answer questions, multiple choice quizzes, group tasks, oral presentations, role plays, scenarios, case studies, work placement journals, logbooks, portfolios and projects Assessments are delivered online via the Canvas LMS
