# **Course structure**

15 core and 3 elective units are delivered over 52 weeks, including 120 hours of work placement:

- 48 weeks of classes and tutorials
- 120 hous of work placement
- 4 weeks holiday breaks

Total course duration can vary depending on student progress.

# Delivery and assessment

This **12 month program** is delivered via self-paced learning using supported e-Learning resources. This learning is complemented with webinars from our trainers and additional study support.

Assessment for this program includes written tasks, long and short answer questions, group tasks, oral presentations, role plays, scenarios, case studies, work placement journals, logbooks, portfolios and projects. Assessments are delivered online via the Canvas LMS.
